In between Board meetings, Directors are owners just like everyone else here, whose privacy and time should be respected. They are not site managers. The Crest does not employ an on-site manager. Insurance Protection

Protect your home and family from unexpected losses. It is highly recommended that all owners obtain and maintain their own Homeowner's insurance (H06) policy to insure individual personal property. For e.g. tv, cameras, computers, furniture, appliances, jewelry & tools. The Crest Associations policy currently carries a \$20,000 deductible.

Reports of feral pigs

Recently, there were reports of property damage by pigs to perimeter unfenced lots.

Simultaneously reports of homeowners feeding pigs were also received. These are the homes along the Crest perimeter, forest conservation area owned by KSBE Kamehameha Schools and Bishop Estate. These areas are on both the Aiea and Pearl City sides of our Crest Assn. By feeding feral animals, they start to view humans as a food source. Feeding feral animals encourages them to travel out from the conservation area, closer towards our back yards. They can lose their fear of humans. Pigs are digging up yards and gardens. Feral animals spread disease, carry bacteria, spread urine, ticks, fleas & bird mites. Pigs can also be dangerous if they feel threatened or are cornered. A kind act may create unintentional consequences for your neighbor's. The Crest Association is not responsible for wild animal control, capture or eradication of feral animals (eg. Pigs, chickens, cats). Pig feeding by just 1 individual, can become a concern for many many other homeowners around them. Please notify Kanani by email, if you see someone feeding these feral animals and include a photo.
